## Federal PLUS Loan Credit Approval Request

You may request a pre-approval for a Federal PLUS Loan by completing and submitting this form to the Westminster College Financial Aid Office. We will determine your loan eligibility, if your credit is approved, for an academic period of up to 12 months. A credit approval is valid for 60 days from the date of inquiry. To avoid additional credit inquiries, please ensure loan applications are accurately completed.
